General Conditions: The consignor agrees to deliver goods to be sold by the consignee, referred to in this document as **Rescue Me! Consignment & Thrift Store Boutique**. **Rescue Me! Consignment & Thrift Store Boutique** agrees to place consignor's goods for sale in the store. **Rescue Me! Consignment & Thrift Store Boutique** will remit 50% of the sales proceeds to the consignor from all items sold during the consignment term. Acceptance of merchandise for sale is at the discretion of **Rescue Me! Consignment & Thrift Store Boutique**. Consignor understands that while **Rescue Me! Consignment & Thrift Store Boutique** agrees to use it's best efforts to obtain a sale of the consigned items, there is no guarantee a sale will occur.

Merchandise Pricing: The selling price of consigned items will be established by **Rescue Me! Consignment & Thrift Store Boutique**. In determining the selling price of items, **Rescue Me! Consignment & Thrift Store Boutique** will consider such factors as brand, age, condition, and market demand.

Item List: Each time items are consigned, a merchandise report referred to in this document as the Item List, will be generated and sent to you via e-mail. The Item List will be given to consignor after items have been priced and placed in the store. It is the responsibility of the consignor to check the Item List for accuracy and update their e-mail information when necessary.. **Rescue Me! Consignment & Thrift Store Boutique** cannot be held responsible for losses resulting from inaccurate or incomplete information on the Item List.

Consignment Term: The consignment term for all items is 90 days. It starts on the day an item is logged into the computer system and an Item List is generated. Included on the item list will be the expiration date. **Rescue Me! Consignment & Thrift Store Boutique** reserves the right to discount consignment items at their discretion. This contract expires at the end of the 90 day term of consignment. Consignor will have a one-time registration fee of \$10. Your account is good as long as you cosign with us!

Payment to Consignors: Consignors can opt for in store credit, payment checks or to have their checks mailed. For items sold during any month payments will be available for the consignor to pick up after the 5th day of the following month. Checks will not be printed for any amount less than \$5.00. If consignor wishes for check to be mailed, they will incur a \$1.00 processing fee.

Expired Items: Consignor will have 7 days to pick up unsold items after the consignment period has expired. It is consignor's responsibility to keep track of when the consignment term ends and to retrieve unsold items within seven days. **Rescue Me! Consignment & Thrift Store Boutique** reserves the right to donate or sell as store-owned merchandise, any unclaimed or unsold items 97 days from the date of consignment.

Items Lost, Stolen, or Damaged: All reasonable care will be taken of items consigned, however they are left at consignor's risk.
